# BID FOR LAWN CUTTING SERVICE NORTHFIELD TOWNSHIP - 2022

Northfield Township is offering the option to those parties that are submitting bids for Snow Removal to also submit a bid for Lawn Care Services for Spring/Summer 2022. Lawn Care bids are not required when submitting Snow Removal bids and will not affect the Snow Contract bidding decision process.

Bids for Lawn Care should be submitted at the time of Snow Removal bid submissions. Northfield Township reserves the right to award or not award a bid for Lawn Care at the time of awarding the bid for Snow Removal.

We are asking for bid pricing options for a 1 year contract, a 2 year contract, and a 3 year contract for Lawn Care and Flower Bed Maintenance at various properties owned by the township. The bids are to be broken down into a price per mow or price per weeding/landscaping for each contract length.

**Season Price Option**: Per season pricing is optional. The Season Price Option would be pricing for the whole season, to be paid in full upfront. If there would be a savings to paying the whole season up front, the approximate percentage saved should be indicated.

### <u>Criteria</u>

Cost should include:

- 1. Trimming around all stationary objects (trees, bushes, parking curbs, flower beds, flag poles, etc.). Company should pay attention to weed growth that might only require occasional trimming.
- 2. Cuttings blown from sidewalks, flower beds, and parking lots every cut.

### **Requirements**

- 1. Must own all equipment needed to accomplish the job.
- Must provide proof of liability insurance showing property damage and public liability coverage in an amount not less than \$1,000,000, showing Northfield Township as additional insured.
  The proof of insurance must be submitted with your sealed bid.
- 3. No less than 3 references from people who have used your services included with your bid.
- 4. Bidders must be in good standing with Northfield Township with no outstanding violations or financial obligations. Contracts will provide for deduction of debts to Northfield Township from payments due under the contract.




